The following bills passed this session:

CS/SB 7014: Raises penalties for in-office and post-office lobbying restrictions to \$20,000 and allows candidates for office to seek costs and fees. These changes were a part of your 2024 legislative recommendations.

The bill also places a two-term limit for members of the Commission. Language in the bill also allows attorneys with confidential clients to simply list "legal client" under the Sources of Income and Secondary Sources of income parts of the Form 6 and Form 1. The bill includes a requirement that complaints filed with the Commission must be "based on personal knowledge or information other than hearsay" as well as language relating to local ethics commissions. The personal information/hearsay standard marks a significant shift in the requirements of complaints filed with our agency. The extent to which this new standard will impact complaints put before the Commission remains to be seen. All aforementioned changes are effective upon signature of the Governor.

A significant portion of the bill is devoted to timeframes for certain complaint processes, including: 30 days for orders to investigate, 150 days for investigations (with 60 days additional if 6 members of the Commission agree). The language in the bill also will require a 2/3 vote of members in attendance to reject a stipulation, rather than a majority vote. Probable cause decisions remain a simple majority vote. The effective date for these changes is October 1, 2024.

This bill has not yet been presented to the Governor for signature.

HB 7005: This bill amends s. 112.31446, F.S., which provides exemptions from public records requirements for secure login credentials held by the Commission and certain information entered into the EFDMS prior to a form being filed. The bill removed the scheduled repeal of the exemption. It was signed by the Governor on March 22, 2024. Its effective date is October 1, 2024.

OTHER BILLS:

There were a number of bills that passed during session, relating to confidentiality exemptions. Once those bills become law, Commission staff will incorporate the changes into redactions on disclosure forms where the filer has requested a confidentiality exemption under s. 119.

Two new boards were created whose members, by statute, will be required to file a Form 1 Statement of Financial Interests: Pinellas County Construction Licensing Board and the Health Care Innovation Council.
