Extension Request 26-16

ORDER ON REQUEST FOR EXTENSION

The Commission on Ethics has received a request for an extension of time to file a CE Form 6, Full and Public Disclosure of Financial Interests, on behalf of the above-referenced individual who, as the Clerk of Court for Santa Rosa County, is required to file an annual CE Form 6 no later than July 1, 2026. A second request¹ for an extension of time to file the 2025 CE Form 6 has been brought by Mr. English stating, as grounds, that his CPA needs additional time to prepare his tax documents in order to complete the Form.

The Commission has delegated to its Chair the authority to grant an extension of up to the statutory maximum of 45 days. Therefore, without a vote of the entire Commission, extensions granted for good cause pursuant to Section 112.3151, Florida Statutes, may not exceed 45 days. Since Mr. English has already received one 45-day extension granted by the Chair, this request has come before the full Commission, as only the full Commission may grant extensions exceeding 45 days for good cause shown pursuant to Section 112.3151, Florida Statutes. Good cause having been shown, the request is hereby GRANTED, and Mr. English shall have an additional 61-day

¹ Mr. English's first request (Extension Request 26-10) was granted by the Commission's Chair on June 25, 2026. Mr. English's first request was granted on the grounds that his CPA needed to gather additional information to complete the Form. The Order granted him an extension of time to file his 2025 CE Form 6 until and including August 15, 2026.

extension until and including October 15, 2026. *Should Mr. English require another extension, he should notify the Commission prior to the end of the October 15, 2026, extension period.*
