MEMORANDUM

To: Commission Members

Subject: Default Final Orders on Financial Disclosure Fines Where There Has Been No Timely Appeal and No Payment

Date: August 13, 2026

Attached is a sample final order that formally imposes the statutory, automatic fines associated with missing the financial disclosure filing deadline. These final orders represent final agency action and close the Commission's proceedings for the individuals listed in this packet, all of whom (1) failed to file or failed to file timely their financial disclosure forms, (2) have not appealed their fines; and (3) have not already paid the fines.

With your approval, staff will process default final orders for each person on the list, consistent with the attached sample final order. Pursuant to the order, upon the expiration of the 30-day period, those currently receiving public funds will be referred for salary withholding. All others will be transmitted to Transworld System, Inc., a collection agency contracted by the Department of Financial Services, for collection.

This matter comes before the Commission on Ethics for the failure of {Filer Name} to pay the assessed fine. Pursuant to Section 112.3145(8)(f), Florida Statutes, the Florida Commission on Ethics is charged with assessing automatic fines of \$25.00 per day up to a maximum of \$1,500.00 for persons who are required to file financial disclosure but who either file late, or not at all.

1. {Filer Name}, {Filer Organization} was on the list of persons required to file a Statement of Financial Interests for the year {Form Year}.
2. Pursuant to Section 112.3145(8)(b)-(c), Florida Statutes, {Filer Name} was mailed a copy of the {Form Year} CE Form 1 no later than June 1, {Filing Year}, and was mailed a delinquency notice by certified mail no later than August 1, {Filing Year}. Additional attempts to contact {Filer Name} were also made by Commission staff.
3. However, {Filer Name} did not file a {Form Year} CE Form 1 before the end of the grace period. {Filer Name} was sent a notice of payment due advising of the statutory rights to appeal or dispute the automatic fine in a hearing before the Commission if such appeal was received within 30 days of the notice of payment due. No timely appeal was received from {Filer Name}.

4. More than 60 days have elapsed since the notice of payment due was transmitted without {Filer Name} paying the fine.

5. On its own motion, the Commission voted to affirm that a fine in the amount of \$1,500.00 has accrued in this matter.

CONCLUSIONS OF LAW

6. The Commission has jurisdiction over the parties to and subject matter of this case, pursuant to Section 112.3145, Florida Statutes.

7. {Filer Name}'s failure to timely appeal the assessed fine constitutes a waiver of the entitlement to an appeal, pursuant to Rule 34-8.215(2), Florida Administrative Code.

ORDER

8. Pursuant to Section 112.3145(8) and 112.31455, Florida Statutes, the Commission on Ethics shall attempt to determine whether {Filer Name} is currently a public officer or public employee receiving salary or wages from a governmental entity. If so, the matter will be referred to either the Chief Financial Officer for the State of Florida or the governing body for {Filer Organization}, as appropriate, for withholding of salary until the debt is satisfied.

9. If {Filer Name} is no longer a public officer or employee, or if the Commission cannot determine filer's status, the matter will be referred to the Florida Department of Financial Services for collection or wage garnishment.

WHEREFORE, the automatic fine that {Filer Name} accrued in the amount of \$1,500.00 is affirmed. The fine shall be paid to the Florida Commission on Ethics within 30 days of the date this Default Final Order is entered. After that date, nonpayment will result in collection as provided for in Section 112.3145(8) and 112.31455, Florida Statutes.
