SECOND ORDER ON REQUEST FOR EXTENSION

The Commission on Ethics has received a request for a second extension of time to file a CE Form 1, Statement of Financial Interests, on behalf of the above-referenced individual who, as a member of the Indian Rocks Beach Planning and Zoning Board, is required to file a 2021 CE Form 1. The first request, which was timely submitted, asked for additional time on behalf of Ms. Warman, as her accountant was busy because it was tax season and could not begin working on her taxes until after October 15, 2022. Based on the request, the Chair granted an extension through October 17, 2022. Ms. Warman timely submitted a second request, in which she asked for additional time to file her 2021 CE Form 1. She stated that her accountant had been busy until October 15, 2022, and that he needed an additional two weeks to provide the information for the Form. Ms. Warman asked that the second extension be through November 1, 2022.

Section 112.3151, Florida Statutes, allows the Commission to grant, for good cause, an extension of time for filing disclosure. Good cause having been shown, the request is hereby GRANTED, and Ms. Warman shall have until and including November 1, 2022, to file her 2021 CE Form 1. The effective date of this extension shall be October 17, 2022.

Although I am a resident of Indian Rocks Beach, I receive my mail at a UPS store in Belleair Bluffs. Notification that I need to fill out the F1 form was sent to my address in Indian Rocks Beach. The US Post Office does not deliver to my home and this is my first year on a city board.

It is therefore that I was not even aware of the necessity of this form until very close to the September 1st deadline. Then, in an attempt to fill out that form, I realized that I do not have the necessary information. My accountant has filed for an extension of October 15th for my 2021 tax return. He has informed me that, as of now, he has no way of estimating my gross income.

My income comes from several sources. One is a Merrill Lynch portfolio and the other sources are 4 multiunit apartment buildings that I own.

I'm writing this letter to request an extension of the September 1st deadline. I am told that the largest extension that can be granted, at this time, is 45 days which would take us to October 15th. ORDER ON REQUEST FOR EXTENSION BY THE CHAIR

The Commission on Ethics has received a request for an extension of time to file a CE Form 1, Statement of Financial Interests, on behalf of the above-referenced individual who, as a member of the Indian Rocks Beach Planning and Zoning Board, is required to file a 2021 CE Form 1 no later than the expiration of the grace period, which is September 1, 2022. In the request, which was timely submitted by Ms. Warman, she explained that her accountant filed for an extension to file Ms. Warman's 2021 federal tax return and that neither he nor she have the ability to determine what her gross income for 2021 was at this time. She also stated that she was unaware of the requirement to file Form 2021 CE Form 1 because the notification was sent to her street address rather than to the UPS store where she receives her mail and the post office does not deliver mail at her street address. Ms. Warman is requesting a 45-day extension.

The Commission has delegated to its chair the authority to grant an extension of up to the statutory maximum of 45 days. Therefore, without a vote of the entire Commission, extensions granted for good cause pursuant to Section 112.3151, Florida Statutes, may not exceed 45 days.

Good cause having been shown, the request is hereby GRANTED, and Ms. Warman shall have an extension until, and including, October 17, 2022.¹

¹ Since the 45-day extension period ends on Sunday, October 16, 2022, the deadline is set for the following business day pursuant to operational law.
