CONSIDERATION OF FINAL ACTION – JOINT STIPULATION

Complaint No. 18-203, In re CHRISTINE ROBERTS

Present were Todd I. Stone, Attorney for the Respondent; and Melody A. Hadley, Commission Advocate.

Ms. Hadley summarized the proposed joint stipulation calling for a finding of violation of Section 112.313(7)(a), Florida Statutes, and a recommended penalty of public censure and reprimand, and a civil penalty of \$1,500.

Commissioner Moore, seconded by Commissioner Fusté, moved to approve the proposed joint stipulation. By unanimous vote, the motion carried.

Complaint No. 22-027, In re ERNESTO TORRES

Present was Elizabeth A. Miller, Commission Advocate.
